

CLARIFICATION TEXT ON PROCESSING OF PERSONAL DATA OF VISITORS

A) Protection of Personal Data and Data Controller

Your personal data are processed within the framework of the Personal Data Protection Law No. 6698 ("PDPL"), the Personal Data Protection Authority regulations and other legislations. In accordance with the relevant laws and regulations, our Company takes all technical and administrative measures to ensure the appropriate level of security in order to prevent unlawful processing or access of your personal data and to ensure its protection. As Data Controller, PIMSA OTOMOTIV A.S. ("Company"), processes your personal data within the scope of the following information and purposes in accordance with the PDPL and the relevant legislations.

B) Purposes of Processing Personal Data

Your personal data transmitted by you while making use of the internet access offered to visitors by our company may also be transferred for the purpose of managing access records and fulfilling our legal obligations with a limitation to the conditions and purposes of personal data processing specified in the Articles 5 and 6 of Law No. 6698.

C) To Whom and For What Purpose Can the Processed Personal Data Be Transferred?

Provided that the above-mentioned purposes are fulfilled, your personal data may be transferred to our business partners, shareholders, affiliates, legally authorized public institutions or private legal persons, in accordance with the conditions and purposes of personal data processing specified in the Articles 8 and 9 of Law No. 6698.

D) Methods and Legal Reason for Collection of Personal Data

Your personal data are collected by our Company on the basis of the legal reasons specified in the paragraphs (b) and (c) above. Your personal data can be collected via your internet access within our Company, your identity certificates, your license plates, orally or through closed circuit camera systems located in our buildings. Your personal data can be processed or transferred for the purposes specified in the paragraphs (b) and (c) of this Clarification Text in accordance with the conditions and purposes of personal data processing specified in the Articles 5 and 6 of Law No. 6698.

E) Your Rights Regarding the Processing of Personal Data

Pursuant to the Article 11 of the PDPL, you may contact our company and request the followings; you have right to:

- a) Learn whether your personal data are processed or not,
- b) Request information if your personal data are processed,
- c) Learn the purpose behind the personal data being processed and to learn whether or not the data is used in accordance with this purpose,
- d) Know the third parties to whom your personal data is transferred at home or abroad,
- e) Request the rectification of the incomplete or inaccurate data, if any,
- f) Request the erasure or destruction of your personal data in accordance with the conditions stipulated in the relevant article of the Law,
- g) Request the notification of the operations carried out in compliance with paragraphs (e) and (f) to third parties to whom your personal data has been transferred,
- h) Object to the processing, exclusively by automated means, of your personal data, which leads to an unfavorable consequence for you,
- i) Request compensation for the damages arising from the unlawful processing of your personal data.

Pursuant to the PDPL, Article 1, subparagraph 1, you may submit your request regarding the exercise of above-mentioned rights to our Company in writing or by other methods determined by the Personal Data Protection Board. Since the Personal Data Protection Board has not determined any method at this stage, you must submit your application to our Company in writing in accordance with the PDPL. In this regard, The channels and procedures to submit your application in writing to our company in accordance with the PDPL, Article 11 are represented below.

For the exercise of above-mentioned rights, you may personally submit your request using a signed petition, including the information identifying your identity and your comments regarding your rights that you would like to utilize among those specified in the Article 12, to the address of Pimsa Otomotiv A.Ş. TOSB Organize Sanayi Bölgesi 1. Cadde 14. Sokak No.8 Şekerpinar, Çayırova/Kocaeli, or you can submit it through a notary public or other methods specified in the PDPL.
